## MONUMENTS COMPLETE

The project to update our four entry monuments was recently successfully completed. All electrical connections were made and the back-lit letters activated. The flood lamps have been disconnected. The monuments were repainted in the color scheme selected by the petitioners. While no color will ever please anyone there seems to be general agreement that the neutral browns selected look good. Especially at night when the letters are back-lit the monuments give our entrances a clean, modern appearance. The Lely Country Club Board will be discussing updating the plantings around the monuments to frame the reconditioned entry signs.

### REVIVING OUR NEIGHBORHOOD WATCH

If you were in attendance at our annual meeting, you heard Corporal Jim Spartz of the Collier County Sheriff's Office talk about reviving the Neighborhood Watch in Lely Country Club. If you believe this is a worthwhile endeavor please step forward to volunteer. Corporate Spartz indicated it is entirely up to our community to manage the program. Initial training will be provided by the Sheriff's Office. Corporal Spartz indicated this would simply involve a power point presentation outlining the dos and don'ts of Neighborhood Watch volunteers. Those interested in volunteering should contact our Community Association Manager Carolyn Sabin at CSABIN@RESORTGROUPINC.COM. She will pass the information along to Corporal Spartz, and will also inform the LCCPOA board of the group's existence. The group must elect a "captain" who will then coordinate whatever meetings the group decides to have. Corporal Spartz indicated there is no requirement to meet regularly. Many groups also meet remotely via Zoom or Facebook. If a Neighborhood Watch group is formed it would probably also be a good idea to appoint someone as a liaison to keep the LCCPOA Board of Directors informed of your activities. LCCPOA's Board would also purchase new Neighborhood Watch signs for our community.



# WHAT'S COOKING STRAWBERRY SHORTCAKE CUPCAKES



#### INGREDIENTS

- 1 1/2 cups all-purpose flour, plus 2 tablespoons
- 1 1/2 teaspoons baking powder
- 1 teaspoon coarse salt
- 1 cup (2 sticks) unsalted butter, room temperature
- 1 cup plus 2 tablespoons granulated sugar
- 4 large eggs, room temperature
- 1/2 teaspoon pure vanilla extract
- 6 tablespoons sour cream, room temperature
- 2 tablespoons good-quality strawberry jam
- 12 ounces strawberries, finely chopped, plus more
- thinly sliced, for topping
- Lightly sweetened whipped cream, for topping



#### **DIRECTIONS**

Step 1: Preheat oven to 325 degrees. Line two 12-cup muffin tins with paper liners. Whisk together flour, baking powder and salt. Cream butter and sugar on medium-high speed until pale and fluffy, about 8 minutes. Add eggs, one at a time, beating thoroughly between each addition, scraping down sides of bowl as needed. Beat in vanilla. Reduce speed to low; add flour mixture in 2 batches, alternating with sour cream and beating until just incorporated.

Step 2: Divide batter evenly among the tins using a 1/4 cup measure or ice cream scoop. Tap pans and smooth tops with an offset spatula or the back of a spoon. Bake until a cake tester inserted into the middle comes out clean, about 30 minutes. Let cool on a wire rack, about 30 minutes.

Step 3: Whisk the jam in a small bowl until smooth. Fold in chopped strawberries. Using a melon baller or teaspoon, scoop out a hole in the center of each cupcake. Fill with 1 to 2 teaspoons strawberry filling. Top with whipped cream and a slice of strawberry. Serve immediately.

# LCCPOA ANNUAL MEETING

Our Association's annual meeting was held on February 21 at Lely Presbyterian Church on St. Andrews Boulevard. A recording of the complete meeting program can be viewed at <a href="https://youtube.com/live/lifkqUzc3Eg">https://youtube.com/live/lifkqUzc3Eg</a>.

Attendance was again well below the 230 property owners required for a quorum, so no official business was conducted by the membership. However, those in attendance and the several members who viewed the live broadcast via the above YouTube link were treated to a great speaking program.

District 1 Collier County Commissioner Rick LoCastro spoke about his experiences and travels around the District since his election in 2020. Commissioner LoCastro urged residents to sign up for his newsletter distributed via email. He said citizens can relay issues to him by responding to the newsletter and he will always respond. The Commissioner gave residents an update on the progress of several projects in the District, including the planned water and sewer line upgrades coming to the Lely community.

The project is currently in the early design phase. No actual construction is likely within the next year or so. He said Lely residents will have an opportunity to comment on the project design. "We don't just start digging up your neighborhood." While anyone can speak at public sessions, he suggested it would be most effective if a small group representative of the majority of the neighborhood would testify.

Commissioner LoCastro was followed by Corporal Jim Spartz of the Collier County Sheriff's Department. Corporal Spartz discussed the status of policing activity in Lely Country Club. Surprisingly the number one "call" to the Sheriff's Office from our neighborhoods were erroneous 911 calls - what he referred to as "911 hangups". There were 49 such calls from Lely Country Club between October 1 and our meeting night. He said the issue is not limited to our neighborhoods. Recently the Sheriff's Office received over 125 "hangups" in a 24-hour period. Overall, he reported that our Lely neighborhoods are safe and secure. He agreed we would benefit, however, by reviving our Neighborhood Watch program. Those volunteering for the Watch would elect a captain. Then Corporal Spartz would meet with the group to explain the "dos and don'ts" of Neighborhood Watch. "It's all about keeping eyes and ears out there" he said.

Commissioner LoCastro and Corporal Spartz stayed on to answer questions from the members and left business cards with contact information.

After the speaking program President Robustelli gave an annual report informing residents of all that was accomplished this past year. Treasurer Waganer presented information on the Association's financial position. There were no matters requiring a vote of the general membership and the meeting was adjourned. Our Board then conducted its annual organizational meeting and elected the following officers for 2023: President: Mark Batchelor, Vice President: Greg Johnson; Secretary: Jason Donahue and Treasurer: Tom Robustelli.
